

**Cornerstone Arts Centre and The Beacon**  
**14 – 25 Membership Scheme**  
**Terms and Conditions**

1. Membership subscription is valid for one member for one calendar year from the date of when membership commences.
2. Membership can be obtained from the website or from the box office in person or via the telephone.
3. Proof of age will be required upon collection of the membership card.
4. Membership and all ticket purchases are non-transferable and non-refundable.
5. Tickets are to be paid for in full at the time of booking
6. Member discounts are subject to agreement with the visiting theatre companies and can't be guaranteed.
7. To be eligible membership, the customer's Spektrix account must include a valid email address and have contact preferences set to allow email communications from Cornerstone Arts Centre and Beacon. This is necessary to ensure Members receive information about priority booking, offers, and promotions.
8. Any change in contact preferences for the Member will invalidate the active Membership.
9. Discounted members' tickets (where available) are restricted to no more than 100 for each performance, thereafter, full price and concessionary tickets are available to members after any advanced booking period expires.
10. 10% discount is also applied to purchases in the Cornerstone Café Bar, Brew and Books or the bar at the Beacon
11. The café bar reserves the right to withhold the discount for special events.
12. Membership discounts are not applied to gallery items or crafts/gifts or performance hire events.
13. Known re-selling or passing on members' tickets to others is strictly prohibited and will result in the immediate cancellation of membership and cancellation of the tickets that have been resold or passed on.
14. Membership benefits may not be used in connection with any other discounted tickets or special offers, unless this is specifically stated in the terms and conditions of the special offer.
15. Each member will be issued with a membership card. Failure to produce your membership card may result in the member benefits not being honoured. Cornerstone and Beacon reserve the right to verify the identity of any member if required.
16. The member named on the card must be present at the time of purchase.
17. Application for a youth membership assumes agreement of reading, understanding and accepting all the membership terms and conditions.
18. Age restrictions will apply to some shows and holders of this membership must adhere to age restrictions. Age restrictions apply to all people attending the performance not just the member.
19. Cornerstone and Beacon reserve the right to suspend, amend or cancel the Membership scheme at any time.
20. Individuals can withdraw from the scheme at any time by contacting the box office.
21. In joining the scheme all members agree to their personal details being held by South Oxfordshire and Vale of the White Horse District Councils. Members also agree to have
